4/12 - A CCI outreach specialist presented to members of the **American Lung Association's Better Breathers Club** at Loma Linda University Medical Center.



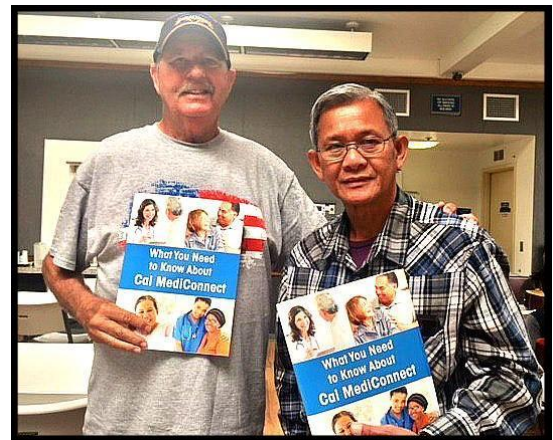
San Bernardino County
