



Associates Membership | 2024 DUES

For those who offer industry-related products/services but do not provide adult day services and do not intend to do so

- CAADS works on behalf of its adult day services provider members (medical, non-medical, and regional center vendorized models) to promote access to quality daytime care for adults with long-term care needs
- Associate members offer goods, services, or support to the adult day services industry, but do not provide adult day services and do not intend to do so

- The CAADS Membership Year is January 1 through December 31. Annual dues are pro-rated according to when you join:

JAN – FEB: 100% of Annual Rate	MAR – APR: 80% of Annual Rate	MAY – JUN: 60% of Annual Rate
JUL – SEPT: 50% of Annual Rate	OCT – DEC: 100% of Annual Rate – up to 15 months for the price of 12!	

Allied Community / Government Organization (Non-Voting Member) ANNUAL DUES: **\$334**

A community based or governmental health or social services organization, association, or network

Examples:

- Area Agency on Aging ■ Association ■ Caregiver Resource Center ■ Educational Institution
- Government Department/Agency ■ MSSP ■ ADS Network ■ Regional Center ■ Residential Care Facility

Those operating, providing, or seeking licensure for an adult day services center/program are ineligible for Allied Community / Government Organization membership. See membership categories, dues, and benefits for ADP, ADHC, ADVP

Consultant (Non-Voting Member) ANNUAL DUES: **\$1,545**

An individual or business offering start-up or operational consulting to adult day service providers

Consultants holding any of the following relationships with one or more ADP, ADHC, or ADVP must bring EACH into membership before becoming eligible for Associate-Consultant membership:

- Stockholder or operating entity ■ Administrator of Record ■ Program Director of Record
- Employee ■ Board Member

Health Care Provider Partner (Non-Voting Member) ANNUAL DUES: **\$1,545**

Licensed healthcare provider partner

Examples:

- Home Health Agency ■ Hospital ■ IPA ■ Knox-Keene Licensed Plan ■ Nursing Facility

Main Office (Non-Voting Member) ANNUAL DUES: **\$139**

A main office membership is in addition to an existing Adult Day Services (ADHC, ADP, ADVP) membership. Main Office membership is limited to one person designated to receive CAADS communications.

This membership category requires ALL adult day services centers/programs affiliated with the main office to be in membership with CAADS.

Vendor (Non-Voting Member) ANNUAL DUES: **\$876**

Businesses offering products or services to adult day service providers.

Vendors who hold any of the following relationships with one or more adult day service centers/programs must bring EACH into membership before becoming eligible for Associate-Vendor membership:

- Stockholder or operating entity ■ Administrator of Record ■ Program Director of Record
- Employee ■ Board Member

Those providing start-up or operational consulting are ineligible for Associate-Vendor membership. See Consultant above.

ADP (non-medical model) Pre-Licensed: Year 1, 2, 3 • Ownership Change • Newly Licensed: Year 1, 2 • Licensed 3 + Years

ADVP (vendorized model) Pre-Vendorized Year 1, 2, 3 • Vendorized Provider

Associate membership is not permitted for those with an ownership or employment (administrator/program director) relationship with one or more adult day services centers unless ALL such centers are in membership with CAADS.
