

MEDI-CAL MANAGED CARE PLANS BY COUNTY (AS OF 2023 AND 2024)

The following table lists Medi-Cal managed care plans (MCPs) by county, as of January 1, 2023, and as they will be effective January 1, 2024. The changes are the result of an agreement among DHCS and MCPs in December 2022 to transform Medi-Cal into a more equitable health system that will result in better health outcomes for Californians. The table also reflects changes based on the County Plan Model changes that were approved in April 2022 and Assembly Bill 2724 enacted June 30, 2022 which added Section 14197.11 to the Welfare and Institutions Code. Starting in 2024, all MCPs will operate under the new restructured and rigorous contract that requires high-quality, equitable and comprehensive coverage.

ii Kaiser Foundation Health Plan, Inc. is the official contract name for Kaiser Permanente. Pending federal approval, Kaiser Permanente will be a plan option in 32 counties for some Medi-Cal members. In Two-Plan, Single Plan and County-Organized Health System model counties, Kaiser participation would be in addition to other plans. Eligible members are those who have been Kaiser Permanente members during the 12 months preceding the effective date of their Medi-Cal eligibility or have a family linkage to a member living in the same home who is a current Kaiser member. Additionally, there will be open choice enrollment for foster youth. Members who are dually eligible for Medicare and Medi-Cal may also enroll in Kaiser. Medi-Cal members enrolled in Kaiser in December 2023 will remain in Kaiser.
