CBAS Guidance Review

- CDA is mindful that current COVID conditions continue to vary around the state.
- CDA currently drafting guidance that will establish directives for the continuing transition to CBAS in-center services
- This guidance will:
 - ⊖ Update the timeline in ACL 21-04
 - Notify providers about upcoming changes to current Public Health Emergency (PHE) flexibilities beginning January 2022, including changes to allowable remote service delivery
- CDA is working to release new guidance by mid-August, ahead of the CDA CBAS Provider Webinar on August 19th at 2:00pm
- If necessary, adjustments to the new timeline will be based on changing conditions with the pandemic and/or new guidance from state partners or other entities (CMS).

Delta Variant Dominates in USA & CA

- **Delta is the major variant** in CA and the USA (> 90%)
- Compared to Alpha (Alpha is the UK variant which is 56% more to than original "wild" virus), Delta:
 - Is 50% more transmissible
 - Produces 1,000 times more virus in nose
 - 4 days to infection compared to 6 days for Alpha
 - Ro = 5-9 (ie, 1 person can infect 5-8 others)
 - Leads to 2x more hospitalizations and 4x more ICU admissions compared with all other variants



CDC: "The War Has Changed"

- 99.5% of COVID-19 deaths in the past few months were among people who weren't vaccinated, and 97% of those currently hospitalized with COVID-19 are unvaccinated (CDC Director Walensky)
- Vaccines are highly protective. Prevent >90% of severe disease.
 - Breakthrough infections among fully vaccinated are expected and generally mild to moderate or asymptomatic.





Delta Transmission Is Exponential

How the R0 numbers of Covid-19 variants and other diseases compare

The more contagious, the higher the R0 number

After 10 cycles of transmission:

- ✓ Ro 2.5 leads to 9,536 cases
- ✓ Ro 6 leads to 60,466,176 cases



The Ro also determines "herd immunity" (Ro-1/Ro):

- ✓ Ro 2.5 = 60%
- ✓ Ro 6 = 84%




CACOVID-19 Numbers as of 8/17/21

The seven-day test **positivity rate** is **5.8%, down .6%** from 7 days prior

5.8% test positivity (7-day rate)


0.6% decrease from 7-days prior



Pandemic of the Unvaccinated


Greater risk of disease, hospitalization and death among unvaccinated vs. vaccinated people: National estimates



Data from COVID Tracker as of July 24, 2021. Average incidence 100 cases per 100.000 persons per week. Vaccine effectiveness against symptomatic illness = 88% (Lopez Bernal et al. <u>NEIM 2021</u>), where risk is [1 – VE] or 12%. Vaccine effectiveness hospitalization [or death] = 96% (Stowe et al. <u>PHE preprint</u>), where risk is [1 – VE] or 4%. Vaccination after COVID-19 Disease

The <u>CDC recommends:</u>

- If you tested positive, had only mild symptoms, and were not treated for the coronavirus, you should:
 - Wait at least 10 days after the start of COVID-19 symptoms, and
 - Meet criteria to stop isolation before getting the COVID-19 vaccine.
- Wait 90 days to get the vaccine if:
 - You recovered from a COVID-19 infection, and
 - Were treated with monoclonal antibodies or convalescent plasma.

Pregnant Women & Vaccination Study

- Studies have shown COVID-19 vaccines are effective and safe to protect pregnant people, fetus, and newborn
- Unvaccinated women were at high risk for preterm birth and other complications and outcomes, if infected with COVID-19, including preeclampsia, coagulopathy, and stillbirth.
- <u>Recent reports</u> have shown that the antibodies developed from mRNA COVID-19 vaccination were present in cord blood and breastmilk samples

Booster Approved for Immunocompromised

- U.S. FDA amended the emergency use authorizations (EUAs) for both the Pfizer-BioNTech COVID-19 Vaccine and the Moderna COVID-19 Vaccine to allow for the use of an additional dose (28 days post initial vaccine series) in certain immunocompromised individuals:
 - 1. solid organ transplant recipients
 - 2. those who are diagnosed with conditions that are considered to have an equivalent level of immunocompromise.
- This does not apply to people who are not immunocompromised.
- These patients should be counseled to maintain physical precautions to help prevent COVID-19. In addition, close contacts of immunocompromised persons should get vaccinated, as appropriate for their health status, to provide increased protection to their loved ones.

Coronavirus (COVID-19) Update: FDA Authorizes Additional Vaccine Dose for Certain Immunocompromised Individuals



Examples of Qualifying Conditions for Booster

- Receiving active cancer treatment for tumors or cancers of the blood
- Received an organ transplant and am taking medicine to suppress my immune system
- Received a stem cell transplant within the last 2 years or am taking medicine to suppress the immune system
- Moderate or severe primary immunodeficiency (such as DiGeorge syndrome, WiskottAldrich syndrome)
- Advanced or untreated HIV infection
- Active treatment with high-dose corticosteroids or other drugs that suppress my immune response



Masking Requirements

- 1. Masks are required for ALL individuals when indoors
- 2. Surgical (medical) masks are required for unvaccinated workers.
- 3. ADHCs and ADPs must strictly adhere to current CDPH Masking Guidance dated July 28, 2021
- 4. Where <u>Title 8 of the California Code of Regulations</u> does not require the use of respirators, facilities shall provide all unvaccinated or incompletely vaccinated workers with <u>FDA-cleared surgical masks</u>.

Vaccines Are the Key to the Future

- "No does not mean "never" sometimes it's a slow getting to "yes"
- Listen and ask open ended questions to understand hesitancy
- Provide 1 on 1 time
- Continue to educate about vaccines
- Discuss need for greater protection measures and higher threat of delta transmission and severe illness for unvaccinated people
- Dispel myths by referring to reliable sources of information
- Support access to vaccination clinics or doctor offices for a shot
 - Follow up on 2-dose vaccines to complete full course of shots

Public Health Orders



July 26, 2021 Order - Unvaccinated Workers in High-risk Settings

Applies to all high-risk care settings including, but not limited to:

- Adult Day Health Care (ADHC)
- Adult Day Programs (ADPs)
- PACE

Full compliance deadline is August 23, 2021

August 5,2021 Order - Healthcare Worker Vaccine Requirement

Applies to healthcare workers only (does not apply to ADPs)

- Adult Day Health Care
- PACE
- >>>> Full compliance deadline is Sept. 30, 2021
 - Exemptions only for medical or religious reasons



What We Know About Mitigation Measures

Maintain 6-foot spacing in center and on transportation



Screen everyone for temperature and signs of infection each day



Wear <u>face coverings or surgical masks when indoors per CDPH</u> guidance for workers (including people not on staff!)



Test unvaccinated workers a minimum of 1x per week using antigen test and report to the state



- Use outdoor space to the extent possible

 - Improve indoor ventilation, as much as feasible



Practice good hand hygiene and infection control measures





What We Know About Vaccination Verification



- 1. Per Public Health Order, ADHC and ADPs must **verify** vaccination status of all workers using acceptable records; **deadline is August 23**.
- 2. "Worker" is broadly defined, employees, contractors, volunteers, etc.
- 3. You must maintain a record




- 4. All unvaccinated or symptomatic workers must undergo testing (either antigen or PCR at least once per week.
- 5. Records of testing results must be maintained
- 6. There are NO exemptions to testing



What We Know About Testing Workers



- 1. All unvaccinated or symptomatic workers must undergo testing (either antigen or PCR at least once per week.
 - Best practice is 2x per week



- 2. Records of testing results must be maintained
- 3. There are NO exemptions to testing unvaccinated people



Options for Complying with Orders for Testing

• Testing Options:

- Statewide BinaxNOWTM Testing Program
- Purchase retail BinaxNOW kits (\$20-\$25 each)
- Use "free" county testing sites or walk-up clinics for confirmatory PCR tests
- PPE supply options (good idea to stock up on supplies now)
 - Retail suppliers
 - CalOES (send order to CDA by the 10th of each month)
 - Adult Day Programs check with your Regional Centers and your regional Community Care Licensing Field Office for drive through events



On-site Testing Considerations

Staffing/Training testing operation.

- Registration, Supervision, Running Tests, Reading/Logging Results.
- Maintaining safety while testing.
 - Testing prior to entering workspace.
 - Using outdoor spaces when appropriate for collection.
 - Staggering staff arrival to accommodate testing schedule.



July 26 Order - Worker Definition



"Worker" refers to **all paid and unpaid persons** serving in health care, other health care or congregate settings who have the **potential for direct or indirect exposure to patients/clients/residents** or SARS-CoV-2 airborne aerosols.

Workers include, but are not limited to, nurses, nursing assistants, physicians, technicians, therapists, phlebotomists, pharmacists, students and trainees, contractual staff not employed by the health care facility, and persons not directly involved in patient care, but who could be exposed to infectious agents that can be transmitted in the health care setting (e.g., clerical, dietary, environmental services, laundry, security, engineering and facilities management, administrative, billing, and volunteer personnel)."

<u>CDSS PIN 21-30-ASC</u> announces availability of the CDPH **BinaxNOW**TM Antigen Testing Program for COVID-19 for Adult and Senior Care Facilities

- Free and available to ADPs and ADHCs
- Free Antigen Testing kits shipped to your center (rapid test 15 minutes)
- You must complete on-line training prior to enrollment (allow for 2-3 weeks to complete all steps)



Advantages of CDPH Antigen Testing Program

- Licensed facilities can obtain a free Clinical Laboratory Improvement Amendments (CLIA) waiver, which is necessary for antigen testing
- Ongoing supplies of Abbott BinaxNOW[™] tests which provide accurate results in approximately 15 minutes
- Tests are easy to perform involving a simple nasal swab
- Tests can be conducted onsite to support decision-making on follow-up
- Infection prevention and control measures (e.g., isolation/cohorting of persons in care and excluding COVID-19 positive cases from entering facility)

- Any staff member can be trained to perform the test
- Ability to test all staff and persons in care
- Facilities may offer tests to screen visitors before entry
- A free and user-friendly platform called Primary to meet the program's reporting requirements
- Ongoing technical and logistical support
- Simple method of enrolling in the program



How to Enroll in Antigen Testing Program

Facilities may directly apply to the CDPH's BinaxNOW[™] Antigen Testing Program through its <u>application webpage</u>.

- Important! When filling out your Antigen Testing Application Form select one of these options under "Type of Organization" drop-down menu
 - Select "Department of Social Services (DSS) facility, if you are an ADP
 - Then, select the appropriate facility type from the "DSS Facility Type" dropdown menu.
 - Select "Other" if you are an ADHC and enter ADHC in the "Other Organization Type" box)
