### **Our Featured Presenter**

Dr. Gandhi completed her M.D. at Harvard Medical School and then came to UCSF in 1996 for residency training in Internal Medicine.

After her residency, Dr. Gandhi completed a fellowship in Infectious Diseases and a postdoctoral fellowship at the Center for AIDS Prevention Studies, both at UCSF. She also obtained a Masters in Public Health from Berkeley in 2001 with a focus on Epidemiology and Biostatistics.

Dr. Gandhi's current research program is on identifying low-cost solutions to measuring antiretroviral levels in resource-poor settings, such as determining drug levels in hair and urine samples. Dr. Gandhi also works on pre-exposure prophylaxis and treatment strategies for HIV infection in women.

SUBJECT: STATEWIDE WAIVERS FOR LICENSING REQUIREMENTS RELATED

TO TUBERCULOSIS (TB) TESTING AND CORONAVIRUS DISEASE

2019 (COVID-19) VACCINE

### Provider Information Notice (PIN) Summary

PIN 21-03-CCLD informs Community Care Licensing Division (CCLD) licensees of the Adult and Senior Care (ASC)\* and Children's Residential (CRP) Programs and licensees and providers and of the Child Care Program (CCP) of a statewide waiver for tuberculosis (TB) testing specific to the timing of COVID-19 vaccinations for licensees, providers, and staff.

\*This PIN provides follow up guidance to an ASC Program alert released via Everbridge on February 5, 2021.

The Centers for Disease Control and Prevention (CDC) has released guidance and an informational letter regarding <u>TB tests and COVID-19 Vaccines</u>, and the unknown potential effects of the COVID-19 vaccine on certain TB test results during the first 4 weeks after COVID-19 vaccination. Based on this information, CCLD is implementing a statewide waiver for TB testing when the individual has received COVID-19 vaccination

### Personnel Requirements Waiver - TB Testing

Personnel requirements set forth in the Health and Safety Code and the California Code of Regulations (CCR) are waived as specified below to enable new staff of CCLD licensees and providers to start working immediately, if the following requirements are met.

TB testing and clearance requirements are waived for new staff and providers who will receive the COVID-19 vaccine, or who have already received the COVID-19 vaccine, to enable them to start work immediately. Although this requirement is waived, a licensee shall conduct a TB screening using the <a href="https://example.com/TB Risk Assessment Questionnaire">TB Risk Assessment Questionnaire</a> prior to beginning employment.

The licensee shall ensure the TB testing and clearance requirements for new staff and providers are met as soon as possible, but no later than five (5) weeks after the staff member received their 2<sup>nd</sup> dose of the COVID-19 vaccine.

- Adult and Senior Care Program Licensees
  - This waiver applies to TB clearance requirements under CCR, Title 22, Division 6, sections 80065, 81065, 85065, 87411, and 87865.
  - o ASC licensees, please see PIN 19-22-ASC as an additional resource.

### TERMS AND CONDITIONS FOR WAIVERS

Licensees and providers may implement the waivers described in this PIN only on an as-needed basis, in a reasonable manner; protecting the confidentiality of a person's medical diagnosis, treatment, and health care information; and in accordance with any guidance or instructions from CDSS, health care providers, CDC, CDPH, and local health departments.

Licensees and providers shall continue to comply with standards that have not been waived in this PIN's statewide waivers or pursuant to a different individual waiver or exception granted by CDSS. Any approved and pending waiver requests for any of the waiver provisions above shall continue to be in force, but shall be replaced by this PIN.

Licensees and providers may continue to request individual waivers for standards not included in these statewide waivers in accordance with PIN 20-04-CCLD.

  - Pharmacies and Clinics vary (CalVax/PrepMod)
    - Sites may offer separate links for second-dose and may offer walk-ins
  - Sites can be either drive-thru or walk-up.

### COVID-19 vaccination: Find out if it's your turn

Everyone in California will have an opportunity to get vaccinated against COVID-19 at no cost. But our vaccination supply is limited right now. So we're starting with the groups who are at highest risk, like people with a high chance of exposure and people 65 and older.

#### Are you eligible?

Find out if it's your turn by answering a few questions. It only takes a few minutes. If you're eligible and vaccine appointments are available through My Turn, you can schedule one. If it's not your turn yet or appointments are not available, you can register to be notified when you're eligible or when appointments open up.

If you're near San Francisco, Los Angeles, or San Diego, you may be able to schedule your appointment today. We are adding appointments to My Turn daily, and expanding statewide.



### Vaccine Prioritization (as vaccine supply allows)

- Currently being distributed to populations identified in Phase 1A and Phase 1B, Tier 1
- Starting March 15, Healthcare providers may vaccinate individuals age 16-64 who are at the highest risk for morbidity and mortality from COVID-19 as a direct result of:
  - Cancer
  - Chronic kidney disease (stage 4 and above)
  - Chronic pulmonary disease (oxygen dependent)
  - Down syndrome
  - Immunocompromised state from solid organ transplant
  - Pregnancy
  - · Sickle cell disease
  - Heart conditions (excludes hypertension)
  - Severe obesity (Body Max Index ≥ 40kg/m2)
  - Type 2 diabetes mellitus (with hemoglobin A1c level greater than 7.5%)





### Vaccine Prioritization (as vaccine supply allows)

### OR...

If as a result of a developmental or other severe high-risk disability one or more of the following applies:

- Individual is likely to develop severe life-threatening illness or death from COVID-19 infection
- Acquiring COVID-19 will limit the individual's ability to receive ongoing care or services vital to their well-being and survival
- Providing adequate and timely COVID care will be particularly challenging due to individual's disability

Note: The list of eligible conditions is subject to change as additional scientific evidence is published and as CDPH obtains and analyzes additional state specific data















### Statewide Estimates of R-effective

The effective reproductive number (R) is the average number of secondary infected persons resulting from a infected person. If R>1, the number of infected persons will increase. If R<1, the number of infected persons will decrease. At R=1, the number of infected persons remains constant.
