# ADHC Membership 2026

## HOW TO APPLY:

1. Access application – [click here](#) for our form or visit [https://caads.org/join\\_now/](https://caads.org/join_now/)
2. Add documents – include all required materials, as stated on the application.
3. Include dues – share your full payment or a signed [Dues Payment Plan](#) with your 1<sup>st</sup> payment. Credit cards are accepted online. Make checks payable to “CAADS” and note there’s a \$50 processing fee for returned checks.
4. Submit everything – email [Membership@caads.org](mailto:Membership@caads.org), or mail to our office.
5. Await approval – the Membership Committee must review and approve all applications. You’ll receive membership confirmation once approved or a refund if not approved.

**Group Membership** – We require Licensees with multiple facilities to bring all of their facilities into the CAADS community via our Group Membership option. Group dues and benefits can be structured in one of two ways:

- Combined Revenue – Combined actual gross revenue for ALL facilities in the Group for the most recent fiscal year end. Allows one Primary Contact Voting Rep for the Group.
- Separate Revenue – Determine actual gross revenue for EACH facility for the most recent fiscal year end. Allows one Primary Contact Voting Rep for each facility.

<b>Newly Licensed</b>	Center in 1 <sup>st</sup> or 2 <sup>nd</sup> year of licensure	Allowed, but must switch to Licensed rates after the 2 <sup>nd</sup> year	Voting Member	<b>\$1,258</b>
<b>Ownership Change</b>	A Center that changed owners	Must switch to Licensed rates after 1 <sup>st</sup> year	Voting Member	<b>\$1,804</b>
<b>Licensed</b>	Center licensed for 3+ years	Unlimited – connected facilities must join as a Group	Voting Member	<b>See the table below.</b>

*\*Those who already own/operate one or more licensed ADS facilities or vendorized ADS programs are **ineligible for Pre-Licensed membership unless all their licensed facilities / vendorized programs are in membership with CAADS.***

Dues are based on actual gross revenue, based on a center or group’s most recent fiscal year end:

The CAADS membership year is January 1 through December 31. Annual dues are prorated according to when you join:

**JAN – FEB:** 100% of Annual Rate

**MAR – APR:** 80% of Annual Rate

**MAY – JUN:** 60% of Annual Rate

**JUL – SEPT:** 50% of Annual Rate

**OCT – DEC:** 100% of Annual Rate – 15 months for the price of 12
